2024 Merrimack County Savings Bank “Dog Days of Summer” Coloring Contest Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN.

MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR: The Merrimack County Savings Bank (The Merrimack) “Dog Days of Summer” coloring contest is sponsored by Merrimack County Savings Bank (Sponsor), PO Box 2826, Concord, NH 03302-2826.

SWEEPSTAKES PERIOD: The Merrimack’s “Dog Days of Summer” coloring contests begins on Wednesday, July 3, 2024, and the submission period ends on Wednesday, July 31, 2024. An internal judging committee will select three (3) winners, one (1) per age group, for each of The Merrimack’s eight (8) branches. Winners will be announced the week of Monday, August 5, 2024.

PRIZE: Three (3) participants, one (1) from each age group, from each of The Merrimack’s eight (8) branches will receive a \$25 cash prize.

AGREEMENT TO OFFICIAL RULES: By participating in The Merrimack’s “Dog Days of Summer” coloring contest, a Parent or Legal Guardian for each entrant agrees to be bound by these Official Rules, including all eligibility requirements, and unconditionally accepts the decisions of the Sponsor, which are final and binding. The contest is subject to all federal, state and local laws and regulations and is void outside the United States and wherever prohibited by law. Prizes may be subject to tax; all applicable taxes are the responsibility of the winner.

ELIGIBILITY: The Merrimack’s “Dog Days of Summer” coloring contest is open to individuals who (a) are legal residents of New Hampshire (b) Are twelve (12) years of age or under at the time of entry. Children of New Hampshire Mutual Bancorp employees and its subsidiaries are eligible to participate in this contest, but cannot collect a cash prize. The Sponsor has the right to verify the eligibility of each entrant before any prize is issued.

ENTRY: Coloring entries must be submitted on The Merrimack’s “Dog Days of Summer” coloring templates available at any branch or **click here to download**. There are three (3) age groups for entry: 5 and under, 6 - 8 and 9 - 12. Submissions will only be accepted at any of The Merrimack’s eight (8) branches located in Bow, Concord, Contoocook, Hooksett, Nashua and Windham. There is no limit to the number of entries that can be submitted.

Mechanically reproduced or potentially fraudulent entries, as determined by Sponsor in its sole discretion, will be discarded.

1. **Assignment of Publication Rights.** We cannot, by law, publish photographs of underage participants on our website, social media pages, or in other publications without explicit permission. For winning entries, the Parent or Legal Guardian will be sent a release form that must be filled out prior to our posting photos of the winning entries.
2. **W9 Form.** A Parent or Legal Guardian of the winning entries needs to submit a W9 before payment is issued and mailed. A member of the Merrimack marketing team will email the W9 form to the Parent or Legal Guardian for completion.

DISQUALIFICATION: Entrant may be prohibited from participating in this contest if Sponsor, in Sponsor's sole discretion, reasonably believes that the entrant has attempted to undermine the legitimate operation of the contest by cheating, deception or other unfair practices, or annoys, abuses, threatens or harasses any other contest entrants, associated individuals or agencies. Any false information provided within the context of the contest by any entrant or noncompliance with these rules or the like may result in the immediate disqualification of the entrant from the contest.

DRAWING AND DISTRIBUTION OF PRIZES: Eligible participants who enter The Merrimack's "Dog Days of Summer" coloring contest and provide their contact information will have the chance to win a \$25 cash prize. Three (3) participants, one (1) from each age group, from each of The Merrimack's eight (8) branches will be chosen by the Sponsor's internal selection committee and will be contacted during the week of Monday, June 24, 2024.

WINNER NOTIFICATION: The Sponsor will contact the winners during the week of Monday, June 24, 2024. If the Sponsor is unable to reach the winner after three (3) attempts or if the winner has not contacted the Bank within 3 days of announcement, another winner will be selected in accordance with official contest rules. The Sponsor will confirm the identity, age, and residency of winner before prize is awarded.

ODDS OF WINNING: The odds of winning are dependent upon the total number of eligible entries received.

ADDITIONAL LIMITATIONS: All prizes are non-transferable. No substitution or cash equivalent of prizes is permitted. The Sponsor may require a Release Form to be completed by a Parent or Legal Guardian of the winner.
