"A Few of Our Favorite Things - Henniker" Sweepstakes Rules & Regulations

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER, WIN, OR VOTE. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR: The Merrimack County Savings Bank ("The Merrimack") "A Few of Our Favorite Things - Henniker" sweepstakes is sponsored by The Merrimack (Sponsor), PO Box 2826, Concord, NH 03302-2826.

SWEEPSTAKES PERIOD: The Merrimack's "A Few of Our Favorite Things - Henniker" sweepstakes begins at approximately 8am Eastern Time ("ET") on Monday, September 16, 2024 and the submission period ends at approximately 5pm ET on Friday, September 27, 2024 (such period, the "Sweepstakes Period").

If a winner does not claim their prize within five (5) days of notification, another eligible entry will be selected and contacted and the first selected entrant will have no further claim to the prize.
