2024 Merrimack County Savings Bank “Pat’s Peak Lift Ticket” Sweepstakes Rules

**NO PURCHASE OR OBLIGATION NECESSARY TO ENTER, WIN, OR VOTE.
MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.**

SPONSOR: The Merrimack County Savings Bank (“The Merrimack”) “Pat’s Peak Lift Ticket” sweepstakes is sponsored by The Merrimack (Sponsor), PO Box 2826, Concord, NH 03302-2826.

SWEEPSTAKES PERIOD: The Merrimack’s “Pat’s Peak Lift Ticket” sweepstakes begins at approximately 8:00 AM Eastern Time (“ET”) on Monday, September 23, 2024 and the submission period ends at approximately 5:00 PM ET on Friday, November 22, 2024 (such period, the “Sweepstakes Period”). Entries received after that date will be deemed ineligible to win.

PRIZE: Ten (10) names will be randomly drawn to win one (1) Lift Ticket, including weekdays and weekends, to Pat’s Peak in Henniker for the 2024-2025 season. Winners must go to The Merrimack branch in Henniker (262 Maple Street) to collect the prize. If a winner does not claim their prize within forty-eight (48) hours of notification, another eligible entry will be selected and contacted and the first selected entrant will have no further claim to the prize. Sponsor will not mail or courier the prize and is not responsible for unclaimed prizes.

AGREEMENT TO OFFICIAL RULES: By participating in The Merrimack’s “Pat’s Peak Lift Ticket” sweepstakes, each entrant agrees to be bound by these Official Rules, including all eligibility requirements, and unconditionally accepts the decisions of the Sponsor, which are final and binding. The sweepstakes is subject to all federal, state and local laws and regulations and is void outside the United States and wherever prohibited by law. Prizes may be subject to tax and reported on a 1099-INT or 1099-MISC; all applicable taxes are the responsibility of the winner.

ELIGIBILITY: The Merrimack’s “Pat’s Peak Lift Ticket” sweepstakes is open to individuals who (a) are legal residents of New Hampshire and (b) are at least eighteen (18) years of age at the time of entry. Employees of New Hampshire Mutual Bancorp and its subsidiaries are not eligible to participate in this contest. Sponsor has the right to verify the eligibility of each entrant before any prize is issued.

ENTRY: To enter the sweepstakes and be eligible to win the prize, fill out the sweepstakes form located at The Merrimack branch in Henniker (262 Maple Street) and drop it in the sweepstakes box on-site. One (1) entry per person.

WINNER SELECTION: Ten (10) names will be randomly drawn, one (1) name per week starting Friday, September 27, 2024 through Friday, November 29, 2024. Entry forms that were not selected will remain in the drawing throughout the sweepstakes period. Winners will be contacted by phone by a Merrimack County Savings Bank representative. The winner must reply within forty-eight (48) hours to maintain eligibility. If a potential winner cannot be contacted within this time period, such potential winner will be disqualified, their entry will be declared null and void and the Sponsor reserves the right, in its sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry.

DISQUALIFICATION: Entrant may be prohibited from participating in this Sweepstakes if Sponsor, in Sponsor's sole discretion, reasonably believes that the entrant has attempted to undermine the legitimate operation of this Sweepstakes by cheating, deception or other unfair practices, or annoys, abuses, threatens or harasses any other contest entrants or associated individuals or agencies. Any false information provided within the context of the Sweepstakes by any entrant or noncompliance with these Rules or the like may result in the immediate disqualification of the entrant from the Sweepstakes. Mechanically reproduced or potentially fraudulent entries, as determined by Sponsor in its sole discretion, will be discarded.
